### **Product Description:**

Bacteria Classification: Francisellaceae, Francisella Species: Francisella tularensis subsp. novicida

Strain: SC92

Comments: Francisella tularensis subsp. novicida, strain SC92 is a transposon mutant of the wild-type strain U112, with a distinct lipopolysaccharide (LPS) phenotype profile. This LPS mutant displayed a diminished ability to grow in mouse macrophages and was sensitive to the detergent deoxycholate.1

Francisella tularensis (F. tularensis) is one of the most infectious bacterial pathogens known and is the causative agent of the febrile zoonotic disease tularemia. The natural reservoir of the bacterium is thought to be rodents, although most human cases result from the bite of a blood-feeding arthropod vector.2

F. tularensis subsp. novicida is a Gram-negative, facultative bacterium, which grows predominantly in macrophages when living in mammalian hosts.<sup>3</sup> It is commonly used for studying F. tularensis pathogenesis since it is highly virulent in mice but has minor effects on humans.2

#### **Material Provided:**

Each vial contains approximately 0.5 mL of bacterial culture in 0.5X Tryptic Soy Broth supplemented with 10% glycerol.

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

## Packaging/Storage:

NR-578 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For longterm storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

#### **Growth Conditions:**

Media:

Tryptic Soy Agar or Broth with 0.1% cysteine Cystine Heart Agar with 5% defibrinated rabbit blood

Incubation:

Temperature: 37°C

Atmosphere: Aerobic with 5% CO<sub>2</sub>

#### Propagation:

- Keep vial frozen until ready for use; thaw slowly.
- Transfer the entire thawed aliquot into a single tube of
- Use several drops of the suspension to inoculate an agar slant and/or plate.
- Incubate the tubes and plate at 37°C for 24 to 48 hours.
