Product Description:

Genomic DNA was isolated from a preparation of *Bacillus* anthracis (*B. anthracis*), strain Sterne BA781 ($\Delta lef243/\Delta cya244/\Delta pagA242$). The designation BA781 refers to the numbering system used in the Stibitz laboratory.

B. anthracis, strain Sterne BA781 (Δ *lef243*/ Δ *cya244*/ Δ *pagA242*) is a derivative of *B.* anthracis, strain Sterne 7702. The Sterne BA781 (Δ *lef243*/ Δ *cya244*/ Δ *pagA242*) strain is a triple deletion mutant.¹ The complete genome of *B.* anthracis, strain Sterne has been sequenced (GenBank: <u>AE017225</u>).²

NR-9544 has been qualified for PCR applications by amplification of approximately 1500 bp of the 16S ribosomal RNA gene. The presence of plasmid pX01 (but absence of the *lef, pag* and *cya* genes) and absence of plasmid pX02 have been confirmed by PCR amplification of plasmid-specific sequences from extracted DNA.

Material Provided:

Each vial contains 4 to 6 μ g of bacterial genomic DNA in TE buffer (10 mM Tris-HCl and 1 mM EDTA, pH ~ 7.4). The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening."

Packaging/Storage:

NR-9544 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
