Original Source: Staphylococcus aureus (S. aureus), strain F339777 was isolated in August 2006 from the buttock of a Stanford Hospital patient in Palo Alto, California, U.S.A.¹

<u>Comments</u>: S. aureus, strain F339777 is a community-associated methicillin-resistant S. aureus (MRSA) strain based on multilocus sequence typing and antibiogram results. Strain F339777 is sensitive to vancomycin and clindamycin but resistant to oxacillin and ciprofloxacin. Note: Methicillin is no longer clinically used, however, the term methicillin-resistant Staphylococcus aureus (MRSA) continues to be used to describe Staphylococcus aureus strains resistant to all penicillins.

S. aureus is a Gram-positive, cluster-forming coccus that normally inhabits human nasal passages, skin and mucus membranes. It is also a human pathogen and causes a variety of pus-forming infections as well as food-poisoning and toxic shock syndrome. In 1961, two years after the introduction of methicillin, a penicillinase-resistant penicillin, S. aureus developed methicillin-resistance due to acquisition of the mecA gene. For the last forty-five years hospital acquired (HA) MRSA strains have disseminated worldwide. More recently, MRSA strains have been isolated that are not hospital acquired and are referred to as communityassociated (CA) MRSA. CA-MRSA strains differ phenotypically and genotypically from HA-MRSA strains and they are more frequently recovered from skin and soft tissue sources rather than post-operative wounds.²

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in 0.5X Brain Heart Infusion Broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-13537 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -80°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Brain Heart Infusion Broth or equivalent Brain Heart Infusion Agar or equivalent

Incubation:

Temperature: 37°C Atmosphere: Aerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- 2. Transfer the entire thawed aliquot into a single tube of broth
- Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate the tube, slant and/or plate at 37°C for 24 hours.
