### **Product Description:**

NR-9349 pairs with NR-9348 to amplify a sequence of approximately 190 nucleotides from the monkeypox virus hemagglutinin (HA) gene.

A Monkeypox Virus Hemagglutinin Gene-Specific Quantitative PCR Assay Detection Kit containing NR-9348 and NR-9349, a TaqMan® probe and a plasmid-based standard is available from BEI Resources (NR-9351). The kit preferentially detects the HA gene of monkeypox virus over the HA genes of other orthopoxviruses and non-orthopoxviruses.

#### **Material Provided:**

Each vial contains approximately 100  $\mu$ L of primer in TE buffer (pH 7.0). The concentration and total primer content is shown on the Certificate of Analysis.

### Packaging/Storage:

Primers were packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -60°C or colder upon arrival. Freezethaw cycles should be minimized.
