# **Product Description:**

NR-42508 is a preparation of total RNA extracted from adult male *Aedes aegypti*, strain Black Eye Liverpool. *A. aegypti* is a vector for three filarial parasites (*Wuchereria bancrofti, Brugia malayi* and *Brugia timori*) that result in lymphatic filariasis when they are transferred to a human host during feeding.<sup>1</sup> In the mosquito, the microfilariae (filarial larval stage) shed their sheath, penetrate the midgut wall and migrate to the thoracic muscles, where they molt twice and finally migrate to the mosquito's proboscis, ready to be transmitted.<sup>2</sup>

#### **Material Provided:**

Each vial of NR-42508 contains approximately 0.5  $\mu$ g to 2  $\mu$ g of DNase-treated RNA in TE buffer (1 mM Tris-HCL, 0.1 nM EDTA, pH ~ 8). Each vial of NR-42508 lot 61378020 contains approximately 0.5  $\mu$ g of DNase-treated RNA in 1 mM sodium citrate, pH ~ 6.4. The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

#### Packaging/Storage:

NR-42508 was packaged in RNase/DNase-free plastic vials. The product is provided frozen and should be stored at -80°C or colder upon arrival. Freeze-thaw cycles should be minimized.
