Product Description:

Genomic DNA was isolated from a preparation of *Burkholderia multivorans* (*B. multivorans*; formerly *Burkholderia cepacia* genomovar II) 1 , strain LMG 13010 (ATCC $^{\odot}$ BAA-247 $^{\text{TM}}$).

The type strain LMG 13010 (CCUG 34080, Lauwers Cepa 002, CIP 105495, DSM 13243, NCTC 13007) was isolated in 1992 from the sputum of a cystic fibrosis patient in Belgium.

The complete genomic sequence for *B. multivorans*, strain LMG 13010 (ATCC[®] BAA-247[™]) is available (GenBank: ALIW00000000).²

NR-36041 has been qualified for PCR applications by amplification of approximately 1500 base pairs of the 16S ribosomal RNA gene.

Material Provided:

Each vial contains approximately 0.7 to 1.5 μ g of bacterial genomic DNA in TE buffer (10 mM Tris-HCl and 1 mM EDTA, pH \sim 8). The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-36041 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
