### **Product Description:**

Bacteria Classification: Spirochaetaceae, Treponema

Species: Treponema denticola

Strain: US-Trep (also referred to as F0459)

<u>Original Source</u>: Treponema denticola (T. denticola), strain US-Trep was isolated from a deep periodontal pocket in an adult human mouth in the United States. 1,2

<u>Comments</u>: *T. denticola*, strain US-Trep (<u>HMP ID 9728</u>) is a reference genome for <u>The Human Microbiome Project</u> (HMP). HMP is an initiative to identify and characterize human microbial flora. The complete genome of *T. denticola*, strain US-Trep was sequenced at the <u>Broad Institute</u> (GenBank: <u>AGEB000000000</u>).

Note: HMP material is taxonomically classified by the depositor. Quality control of these materials is only performed to demonstrate that the material distributed by BEI Resources is identical to the deposited material.

*T. denticola* is a Gram-negative, obligately anaerobic, nonsporulating, motile spirochete usually found in the microflora of a human mouth, predominately in the subgingival plaque of patients with periodontitis.<sup>3</sup> This invasive bacterium has been identified as an important cause of periodontal disease and suspected to be involved in extra-oral infections.<sup>4-7</sup>

#### **Material Provided:**

Each vial contains approximately 0.5 mL of bacterial culture in tryptone-yeast extract-gelatin-volatile fatty acids-serum (TYGVS) medium supplemented with 80% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

### Packaging/Storage:

HM-573 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freezethaw cycles should be avoided.

#### **Growth Conditions:**

TYGVS medium<sup>1</sup> or Modified New Oral Spirochete broth<sup>3</sup> or equivalent

Note: Growth on agar is not recommended.

Incubation:

Temperature: 37°C Atmosphere: Anaerobic

**Propagation:** 

- Keep vial frozen until ready for use, then thaw.
- Transfer the entire thawed aliquot into a single tube of broth.
- Use several drops of the suspension to inoculate additional broth tubes.
- 4. Incubate tubes at 37°C for 3 to 7 days.
