Strain: A/swine/Ohio/09SW79M/2009 (H3N2)

Original Source: Influenza A virus, A/swine/Ohio/ 09SW79M/2009 (H3N2) was isolated from a swine in Ohio, USA on August 8, 2009.

<u>Comments</u>: Sequence information is available for influenza A virus, A/swine/Ohio/09SW79M/2009 (H3N2) at the Influenza Research Database.

### **Material Provided:**

Each vial contains approximately 1 mL of cell lysate and supernatant from Madin-Darby Canine Kidney (MDCK) cells (ATCC $^{\otimes}$  CCL-34 $^{\mathrm{TM}}$ ) infected with influenza A virus, A/swine/Ohio/09SW79M/2009 (H3N2).

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

# Packaging/Storage:

NR-36706 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

### **Growth Conditions:**

Host: MDCK cells (ATCC® CCL-34™)

Growth Medium: Dulbecco's Modified Eagle Medium supplemented with 0.5 μg per mL L-1-tosylamido-2-phenylethyl chloromethyl ketone (TPCK)-treated trypsin

<u>Infection</u>: Cells should be 100% confluent <u>Incubation</u>: 3 to 7 days at 37°C and 5% CO<sub>2</sub>

Cytopathic Effect: Cell rounding, clumping, and sloughing
