Material Provided:

Each vial contains approximately 1 mL of pooled allantoic fluid from specific pathogen free (SPF) embryonated chicken eggs infected with influenza A virus, A/shorebird/Delaware Bay/338/2009 (H10N1).

Packaging/Storage:

NR-45173 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

<u>Host</u>: 9- to 11-day-old SPF embryonated chicken eggs <u>Infection</u>: Embryonated chicken eggs must be candled for viability prior to inoculation

Incubation: 2 days at 35°C in a humidified chamber

<u>Effect</u>: Hemagglutination activity using chicken red blood cells and allantoic fluid from infected embryonated chicken eggs
