Material Provided:

Each vial contains approximately 1 mL of cell lysate and supernatant from Madin-Darby Canine Kidney (MDCK) cells (ATCC $^{\otimes}$ CCL-34 $^{\mathrm{TM}}$) infected with influenza A virus, A/swine/Ohio/11SW128/2011 (H1N2).

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-36716 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Host: MDCK cells (ATCC® CCL-34™)

<u>Growth Medium</u>: Eagle's Minimum Essential Medium supplemented with 0.225% bovine serum albumin and 2.0 µg/mL L-1-tosylamido-2-phenylethyl chloromethyl ketone (TPCK)-treated trypsin

Infection: Cells should be 95 % to100% confluent Incubation: 2 to 6 days at 37°C and 5% CO₂

Cytopathic Effect: Cell rounding and detachment
