Original Source: *Prevotella denticola* (*P. denticola*), strain DNF00960 was isolated in December, 2011, from vaginal fluid collected from a woman that tested positive for bacterial vaginosis in the United States.<sup>1</sup>

Comments: *P. denticola*, strain DNF00960 ([HMP ID 2139](#)) is a reference genome for [The Human Microbiome Project](#) (HMP). HMP is an initiative to identify and characterize human microbial flora. The complete genome of *P. denticola*, strain DNF00960 was sequenced at the [J. Craig Venter Institute](#) (GenBank: [JRNO00000000](#)).

Note: HMP material is taxonomically classified by the depositor. Quality control of these materials is only performed to demonstrate that the material distributed by BEI Resources is identical to the deposited material.

*P. denticola* is a Gram-negative, obligately anaerobic, rod-shaped bacterium commonly found in the microflora of a normal human mouth. It is an opportunistic pathogen known for involvement in patients with periodontal disease.<sup>2-5</sup>

#### Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Modified Reinforced Clostridial broth supplemented with 5% DMSO.

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

#### Packaging/Storage:

HM-1173 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

#### Growth Conditions:

##### Media:

Modified Chopped Meat medium or Modified Reinforced Clostridial broth or equivalent

Tryptic Soy agar with 5% defibrinated sheep blood or equivalent

##### Incubation:

Temperature: 37°C

Atmosphere: Anaerobic

##### Propagation:

1. Keep vial frozen until ready for use, then thaw.
2. Transfer the entire thawed aliquot into a single tube of broth.
3. Use several drops of the suspension to inoculate an agar slant and/or plate.
4. Incubate the tube, slant and/or plate at 37°C for 48 to 72 hours.
