## **Product Description:**

Genomic RNA was isolated from a preparation of cell lysate and supernatant from human rhabdomyosarcoma cells infected with enterovirus D68 (EV-D68), US/IL/14-18952.

EV-D68, US/IL/14-18952 was isolated from a nasopharyngeal swab taken from a human in Illinois, USA, in August, 2014. A nearly complete genome of EV-D68, US/IL/14-18952 has been sequenced (GenBank: KM851230).

NR-49136 has been qualified for PCR applications by amplification of an approximately 1100 nucleotide sequence. Recommended dilutions for successful RT-PCR amplification are indicated on the Certificate of Analysis for each lot.

#### **Material Provided:**

Each vial contains 100  $\mu$ L of viral genomic RNA in TE buffer (10 mM Tris-HCl, 1 mM EDTA, pH 7.0). The viral genomic RNA is in a background of cellular nucleic acid and carrier RNA. The vial should be centrifuged prior to opening.

## Packaging/Storage:

NR-49136 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -60°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
