Reagent: NR-29335 is a preparation of early-immune serum from a non-human primate (NHP) that was immunized by subcutaneous injection of 0.5 mL of live attenuated yellow fever virus vaccine (17D). Serum was collected on day 30.

Material Provided:

Each vial contains approximately 50 μL of early-immune yellow fever virus antiserum.

Packaging/Storage:

NR-29335 was packaged in screw-capped plastic cryovials. The product is provided frozen and should be stored at -70°C or colder immediately upon arrival.
