Antiserum to COWP1 of *Cryptosporidium parvum* was produced by intradermal immunization of a three month old rabbit with three COWP1 peptides conjugated to keyhole limpet hemocyanin (KLH).

Material Provided:

NR-4937 is distributed as a three vial kit. The kit contains pre-bleed (NRC-1052), first bleed (NRC-1053) and second bleed (NRC-1054) rabbit polyclonal antiserum. Each vial contains approximately 0.05 mL (pre-bleed), 0.2 mL (first bleed) and 0.38 mL (second bleed) of rabbit polyclonal antiserum.
