### **Product Description:**

Antiserum to COWP6 of *Cryptosporidium parvum* was produced by intradermal immunization of a three month old rabbit with three COWP6 peptides conjugated to keyhole limpet hemocyanin (KLH).

#### **Material Provided:**

NR-9602 is distributed as a three vial kit. The kit contains pre-bleed (NRC-1873), first bleed (NRC-1874) and second bleed (NRC-1875) rabbit polyclonal antiserum. Each vial contains approximately 0.13 mL (pre-bleed), 0.42 mL (first bleed) and 0.36 mL (second bleed) of rabbit polyclonal antiserum.

NR-9602 is reactive with COWP6 of *Cryptosporidium parvum* by ELISA and western blot analysis as communicated by the contributor.
