Antiserum to COWP7 of *Cryptosporidium parvum* was produced by intradermal immunization of a three month old rabbit with three COWP7 peptides conjugated to keyhole limpet hemocyanin (KLH).

Material Provided:

NR-9604 is distributed as a three vial kit. The kit contains pre-bleed (NRC-1879), first bleed (NRC-1880) and second bleed (NRC-1881) rabbit polyclonal antiserum. Each vial contains approximately 0.13 mL (pre-bleed), 0.42 mL (first bleed) and 0.36 mL (second bleed) of rabbit polyclonal antiserum.
