Product Description:

Bacteria Classification: Bacillaceae, Bacillus

<u>Species</u>: Bacillus thuringiensis (NR-28583 was deposited to BEI Resources as Bacillus cereus, however, digital DNA-DNA hybridization (dDDH) testing¹ performed at BEI Resources, resulted in reclassification of the species to thuringiensis.)

Strain: BAG10-3

<u>Original Source</u>: *Bacillus thuringiensis* (*B. thuringiensis*), strain BAG1O-3 was isolated in 2009 from a soil sample collected in Boston, Massachusetts, USA.²

<u>Comments</u>: *B. thuringiensis*, strain BAG1O-3 is part of a <u>Bacillus cereus</u> Database Sequencing Project at the <u>Broad Institute</u>. The complete genome sequence of <u>B. thuringiensis</u>, strain BAG1O-3 is available (GenBank: <u>AHCP000000000</u>).

B. thuringiensis is a Gram-positive bacterium commonly found in soil. It is well known for the production of insecticidal toxin during sporulation.³ A large number of strains have been isolated from dead insects, most notably the lepidopterous species (moths and butterflies). Many of the toxin genes that are specific for a variety of insects have been studied and are being used in genetically modified plants, which have been engineered to produce the toxin themselves.³

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-28583 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Media:

Tryptic Soy broth or Nutrient broth or equivalent

Tryptic Soy agar or Tryptic Soy agar with 5% defibrinated sheep blood or Nutrient agar or equivalent

Incubation:

Temperature: 28°C to 37°C Atmosphere: Aerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- Transfer the entire thawed aliquot into a single tube of broth.
- Use several drops of the suspension to inoculate an agar slant and/or plate.
- Incubate the tube, slant and/or plate at 37°C for 1 to 2 days.
