<u>Classification</u>: Psychodidae, Phlebotominae, Phlebotomus <u>Species</u>: Phlebotomus papatasi (common name: sand fly) <u>Strain</u>: Turkey (often referred to as PPTK)

Original Source: Phleobotomus papatasi (P. papatasi), strain Turkey was collected by E. Rowton in Turkey.

<u>Transmission Competent Pathogens</u>: Leishmania major, Naples, Sicilian and Toscana phlebovirus

<u>Comment</u>: The whole genome sequence of a representative *P. papatasi* colony is available (GenBank: AJVK00000000).

#### **Material Provided:**

NR-44000 consists of 1 larval pot of *P. papatasi* (sand flies), containing mixed L3/pupae life stages. Registrants may order up to 6 larval pots per year.

Note: P. papatasi, strain Turkey (PPTK) can also be obtained in adult form (NR-44014).

This material is prepared and shipped at room temperature from Walter Reed Army Institute of Research, Maryland, USA.

## **Growth Conditions:**

Rabbit feces and rabbit chow mixture (larvae)

Temperature: 25-26°C

Atmosphere: 80% relative humidity.2

Infectivity/Method for Experimental Use: Oral membrane feed

or infected animal feed.3

Note: Larval pots may contain phorid mites which are a normal occurrence in sand fly colonies.
