<u>Original Source</u>: *Lactobacillus gasseri (L. gasseri*), strain PSS7772D was isolated in 2014 from urine of a pregnant female in St. Louis, Missouri, USA. ^{1,2}

<u>Comments</u>: *L. gasseri*, strain PSS7772D (<u>HMP ID 3210</u>) is a reference genome for <u>The Human Microbiome Project</u> (HMP). HMP is an initiative to identify and characterize human microbial flora. The complete genome of *L. gasseri*, strain PSS7772D was sequenced at the Genome Institute at <u>Washington University</u> (GenBank: <u>LRQD000000000</u>).

Note: HMP material is taxonomically classified by the depositor. Quality control of these materials is only performed to demonstrate that the material distributed by BEI Resources is identical to the deposited material.

L. gasseri is a Gram-positive, mesophilic, non-motile facultative anaerobe bacterium that is commonly found in the normal human gastrointestinal tract. It is commonly used in the production of yogurt and other dairy products and has also been shown to be an effective probiotic in suppressing *Helicobacter pylori* infections in humans.³

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Lactobacilli MRS broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

HM-1278 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Media:

Lactobacilli MRS broth or NYC III broth or equivalent Lactobacilli MRS agar or Tryptic Soy agar with 5% defibrinated sheep blood or equivalent Incubation:

Temperature: 37°C

Atmosphere: Anaerobic or aerobic with 5% CO₂

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- 2. Transfer the entire thawed aliquot into a single tube of broth
- Use several drops of the suspension to inoculate an agar slant and/or plate.
- Incubate the tube, slant and/or plate at 37°C for 1 to 2 days.
