Original Source: Bacteriophage phi05\_1999B/Ec2424 was isolated from a blood sample taken from a patient with septicemia.1

Comments: Bacteriophage phi05\_1999B/Ec2424 (HMP ID 9787) is a reference genome for The Human Microbiome Project (HMP). HMP is an initiative to identify and characterize human microbial flora. The complete genome of bacteriophage phi05\_1999B/Ec2424 was sequenced at the J. Craig Venter Institute (Genbank: ASM306058v1).

HMP material is taxonomically classified by the Quality control of these materials is only depositor. performed to demonstrate that the material distributed by BEI Resources is identical to the deposited material.

Bacteriophage phi05\_1999B/Ec2424 is a highly selective virus that is extremely effective at lysing E. coli, a major facultative inhabitant of the large intestine.1,2 Bacteriophage phi05\_1999B/Ec2424 belongs to the unclassified Podoviridae family of viruses<sup>1</sup>, which are non-enveloped and display short, noncontractile tails, linear dsDNA and icosehedral capsids.3

## **Material Provided:**

Each vial contains approximately 0.5 mL of bacteriophage in Luria-Burtani (LB) broth supplemented with 10 mM MgSO<sub>4</sub> and glycerol (see Certificate of Analysis for lot specific information).

## Packaging/Storage:

HM-677 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -20°C or colder immediately upon arrival. For long-term storage, the product should be stored at -80°C or colder or in the vapor phase of a liquid nitrogen freezer. Freeze-thaw cycles should be avoided.

Note: Host homogeneity is recommended for your intended use, please colony-purify your bacterial host prior to use.

- Keep bacterial stock frozen until ready for use, then thaw.
- Transfer a thawed aliquot into a single tube of broth.
- Incubate the tube at 37°C for 1 day.

Growth medium for bacteriophage:

LB agar supplemented with 10 mM MgSO<sub>4</sub> or equivalent LB soft agar overlay (0.7%) supplemented with 10 mM MgSO<sub>4</sub> or equivalent

Incubation of host with bacteriophage:

Temperature: 30°C Atmosphere: Aerobic Propagation of bacteriophage:

- Prior to opening the vial, an actively growing broth culture (1-day incubation) of the recommended host strain should be prepared. Keep bacteriophage vial frozen until ready for use, then thaw.
- 2. Pre-warm plates and overlay the surface with 2.5 mL of melted 0.7% agar containing 1 to 2 drops of the host. Allow overlay to harden.
- 3. Prepare serial dilutions of thawed bacteriophage (if desired) and spot onto the plate. Allow to dry.
- Incubate the plate at 30°C for 1 day.

Note: Spotting the phage on plates makes visualizing the lysis easier. If phage is added directly to soft-agar before pouring plates, hazy or tiny plaques may be difficult to see. Resistant host bacteria may also mask plaque formation.

Cytopathic Effect: Lysis of E. coli; individual plagues should be countable at higher dilutions.
