The Tissue Culture Infectious Dose 50% (TCID $_{50}$ ) endpoint is the 50% infectious endpoint in tissue culture. The TCID $_{50}$  is the dilution of virus that under the conditions of the assay can be expected to infect 50% of the cultures inoculated, just as a Lethal Dose 50% (LD $_{50}$ ) is expected to kill half of the animals exposed. A reciprocal of the dilution required to yield the TCID $_{50}$  provides a measure of the titer (or infectivity) of a virus preparation.
