<u>Species</u>: Anopheles gambiae (African malaria mosquito) (The mosquito species complex Anopheles gambiae M form strains may also be referred to as Anopheles coluzzii, since a new species designation for these strains has been proposed.)¹

Strain: Mali-NIH

Original Source: The Anopheles gambiae (An. gambiae), strain Mali-NIH colony was established from blood-fed adult females collected resting inside houses in Niono, Mali in June 2005. Approximately 80 isofemale families molecularly identified as An. gambiae M form were used to establish the colony, which was subsequently karyotyped as 2Rbc/bc; 2La/a.^{2,3}

<u>Comments</u>: The *An. gambiae*, strain Mali-NIH colony is the source of DNA for the *An. gambiae* M form genome sequencing project (GenBank: <u>ABKP00000000</u>) supported by the National Human Genome Research Institute (NHGRI).³

<u>Applications</u>: MRA-860B is suitable for DNA and RNA isolation, protein extraction, etc.

Material Provided:

Each tube of MRA-860B contains at least 100 adult male and female wild-type *An. gambiae*, strain Mali-NIH mosquitoes preserved in liquid nitrogen (quick-frozen).⁴

Packaging/Storage:

MRA-860B is prepared and shipped by CDC. The product is provided frozen and should be stored at -80°C or colder immediately upon arrival.
