# **Product Description:**

Genomic DNA was extracted from a preparation of *Encephalitozoon hellem (E. hellem)*, CDC:0291:V213, which was isolated in 1991 from the urine of an adult human male AIDS patient in Georgia, USA.<sup>1</sup>

NR-34574 has been qualified for PCR applications by amplification of approximately 1200 base pairs of 18S ribosomal RNA.

### **Material Provided:**

Each vial contains 0.2 to 3.5  $\mu$ g of fungal genomic DNA in 10 mM Tris-HCl and 1 mM EDTA, pH 7.5. The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

# Packaging/Storage:

NR-34574 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
