Characteristics:

Obtained from EBV-immortalized peripheral blood mononuclear cells from HIV-seropositive individuals. This antibody is anti-p24, and reacts with HIV lysate in ELISA. It reacts with the p55 core precursor as well as p24 and several intermediates

as determined by Western blot. The antibody stains the cytoplasm of HIV infected cell lines. Antibody is in RPMI 1640 with 15% fetal bovine serum.

Recommended

Storage:

Keep at 4°C for short term storage and -80°C for long term storage. Avoid freeze-thaw

cycles as reagent degradation may result.
