Product Description:

A recombinant form of the spike (S) glycoprotein receptor binding domain (RBD) from severe acute respiratory syndrome-related coronavirus 2 (SARS-CoV-2), V483A variant was produced by transient transfection in human embryonic kidney HEK293 cells and purified by affinity chromatography and buffer exchange. NR-55409 lacks the signal sequence, contains 223 residues of the SARS-CoV-2 S glycoprotein (amino acid residues R319 to F541) and features a C-terminal poly-histidine tag. NR-55409 is a variant of SARS-CoV-2 which contains the V483A mutation in the S glycoprotein as compared to the SARS-CoV-2 reference sequence (GenPept: <u>QHD43416</u>). NR-55409 lot 3764b-212GF1-W7 was lyophilized from 164 µL bulk protein in phosphate-buffered saline, pH 7.4 with 10% trehalose.
