<u>Original Source</u>: *Prevotella nigrescens (P. nigrescens)*, strain CC14M was isolated in October 2010 from colonic biopsy tissue of a human subject in Victoria, British Columbia, Canada.¹

<u>Comments</u>: *P. nigrescens*, strain CC14M (<u>HMP ID 1173</u>) is a reference genome for <u>The Human Microbiome Project</u> (HMP). HMP is an initiative to identify and characterize human microbial flora. The complete genome of *P. nigrescens*, strain CC14M was sequenced at the <u>Broad Institute</u> (GenBank: <u>AZJH000000000</u>).

Note: HMP material is taxonomically classified by the depositor. Quality control of these materials is only performed to demonstrate that the material distributed by BEI Resources is identical to the deposited material.

P. nigrescens is a Gram-negative, obligately anaerobic, non-motile, non-sporulating, rod-shaped bacterium commonly found in the microflora of the human mouth, particularly in patients with periodontal disease. ^{2,3} Although not viewed as virulent as some oral microorganisms, *P. nigrescens* has been associated with an increased risk of periodontitis and future coronary heart disease. ³

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Modified Chopped Meat medium supplemented with 5% dimethylsulfoxide (DMSO).

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

HM-1053 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Media

Modified Chopped Meat medium or equivalent

Fastidious Anaerobe agar with 5% sheep blood¹ or Tryptic Soy agar with 5% sheep blood or equivalent

Incubation:

Temperature: 37°C Atmosphere: Anaerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- 2. Transfer the entire thawed aliquot into a single tube of broth
- Use several drops of the suspension to inoculate an agar slant and/or plate.
- Incubate the tube, slant and/or plate at 37°C for 2 to 3 days.
