# **Product Description:**

Genomic DNA was extracted from a preparation of *Bacillus* sp., strain 1180.

*Bacillus* sp. (*B.* sp.), strain 1180 was originally isolated by P. Fitz-James and deposited at ATCC<sup>®</sup> by the University of Western Ontario as *B. cereus* subsp. *israelensis. Bacillus* sp., strain 1180 was previously classified as *Bacillus thuringiensis*; however, in-house sequencing and digital DNA-DNA Hybridization (dDDH) data was only able to confirm to the genus level.

# **Material Provided:**

Each vial contains approximately  $0.7 \ \mu g$  to  $1.5 \ \mu g$  of genomic DNA in TE buffer (10 mM Tris-HCl and 1 mM EDTA, pH 8 to 8.5). The vial should be centrifuged prior to opening.

#### Packaging/Storage:

NR-52279 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -20°C or colder immediately upon arrival. For long-term storage, the product should be stored at -80°C. Freeze-thaw cycles should be minimized.
