NR-45936 was produced by inoculation of the deposited material into Tryptic Soy broth and grown 24 hours at 37°C in an aerobic atmosphere. Broth inoculum was added to Tryptic Soy agar with 5% defibrinated sheep blood kolles which were grown 24 hours at 37°C in an aerobic atmosphere to produce this lot.

³S. aureus, strain RN0027 is reported to be non-β-hemolytic due to the integration of Φ13 in *hlb*. Hemolysis observations were performed in duplicate and determined strain RN20027 is β-hemolytic. 


Figure 1: Colony Morphology
