1S. aureus, strain NY-51 was deposited to BEI Resources as part of the NARSA collection. NR-46246 was produced by inoculation of the deposited material into Tryptic Soy broth and grown 1 day at 37°C in an aerobic atmosphere. Broth inoculum was added to Tryptic Soy agar kolles which were grown 1 day at 37°C in an aerobic atmosphere to produce this lot.
