Product Description:

Diarrheagenic *Escherichia coli* (*E. coli*) are classified into several pathogenic groups based on their virulence characteristics. NR-12195 contains forward and reverse primers that specifically amplify a region of the virulence target, CVD432, found on the virulence plasmid, pAA, of enteroaggregative *E. coli* (EAggEC).^{1,2}

Material Provided:

Each vial contains approximately 100 µL of a mixture of forward and reverse primers in TE buffer (pH 7.0). The concentration is shown on the Certificate of Analysis.

Note: *E. coli* 12-Target Multiplex PCR 10X Buffer (BEI Resources NR-13440) will be provided with your shipment of NR-12195.

Packaging/Storage:

Primers were packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -60°C or colder upon arrival. Freeze-thaw cycles should be minimized.
