## **Product Description:**

Antibody Class: IgG2aκ

Mouse monoclonal antibody prepared against the nonstructural protein 1 (NS1) of West Nile virus (WNV) was purified from clone 22-NS1 hybridoma supernatant by protein G affinity chromatography. The B cell hybridoma was generated by the fusion of P3X63.Ag8.53 BALB/c mouse myeloma cells with immunized mouse splenocytes. The clone 22-NS1 antibody is reported to bind to domain II-III in the NS1 glycoprotein.<sup>1,2</sup>

### **Material Provided:**

Each vial of NR-10145 contains approximately 100  $\mu$ L of purified monoclonal antibody in PBS. The concentration, expressed as mg per mL, is shown on the Certificate of Analysis.

## Packaging/Storage:

NR-10145 was packaged aseptically in screw-capped plastic cryovials and is provided frozen on dry ice. NR-10145 should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be avoided.

## **Functional Activity:**

NR-10145 is reactive in immunofluorescence assays using Vero cells infected with WNV and by ELISA using WNV-infected cell lysates [WNV, Eg101 (Egypt 1951); BEI Resources NR-676]. The antibody is reported to be reactive using flow cytometry and Western blot analysis.<sup>3</sup>
