Product Description:

Antibody Class: IgG2b κ

Mouse monoclonal antibody prepared against the envelope glycoprotein of dengue virus type 1 (DEN-1) was purified from clone E59 hybridoma supernatant by protein G affinity chromatography. The B cell hybridoma was generated by the fusion of P3X63.Ag.8.6.5.3 BALB/c mouse myeloma cells with immunized mouse splenocytes. The clone E59 antibody is reported to bind to domain III in the envelope glycoprotein.¹

Material Provided:

Each vial of NR-4762 contains approximately 100 μ L of purified monoclonal antibody in PBS.

Packaging/Storage:

NR-4762 was packaged aseptically in screw-capped plastic cryovials and is provided frozen on dry ice. NR-4762 should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be avoided.

Functional Activity:

NR-4762 is reactive by ELISA using DEN-1-infected cell lysates (DEN-1, Hawaii; BEI Resources NR-82). The antibody is reported to have weak neutralizing activity, to be reactive using flow cytometry and to cross-react with dengue virus type 3.¹
