Antibody class: IgMκ

Mouse monoclonal antibody against purified protein from *Cryptosporidium parvum* (*C. parvum*) oocyst wall was produced *in vitro* from hybridoma clone 6D9.27.

Material Provided:

Each vial contains approximately 1 mL of NR-14806 in culture medium.

Packaging/Storage:

NR-14806 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -20°C or colder immediately upon arrival.

Functional Activity:

NR-14806 stains *C. parvum* oocysts in indirect immunofluorescence assays. The antibody has been reported to react with *C. parvum* oocyst wall in ELISA, immunohistochemistry and Western blot assays.¹
