Mouse monoclonal antibody against purified protein from *Cryptosporidium parvum* (*C. parvum*) oocyst wall was produced *in vitro* from hybridoma clone 16E7.

**Material Provided:**

Each vial contains approximately 1 mL of NR-14810 in culture medium.

**Packaging/Storage:**

NR-14810 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -20°C or colder immediately upon arrival.

**Functional Activity:**

NR-14810 stains *C. parvum* oocysts in indirect immunofluorescence assays. The antibody has been reported to react with *C. parvum* oocyst wall in ELISA, immunohistochemistry and Western blot assays.<sup>1</sup>
