**Product Description:**

Genomic DNA was obtained from a preparation of *Bacteroides ovatus* (*B. ovatus*), strain 3\_8\_47FAA. Note: The HMP material used for DNA extraction was taxonomically classified by the depositor. Quality control of HMP organisms is only performed to demonstrate that the material produced by BEI Resources is identical to the deposited material.

*B. ovatus*, strain 3\_8\_47FAA was isolated from inflamed biopsy tissue taken from the sigmoid colon of a 25-year-old female patient with Crohn's disease.<sup>1</sup> *B. ovatus*, strain 3\_8\_47FAA ([HMP ID 1017](#)) is a reference genome for [The Human Microbiome Project](#) (HMP). HMP is an initiative to identify and characterize human microbial flora. The complete genome of *B. ovatus* 3\_8\_47FAA is currently being sequenced at the [Broad Institute](#) (GenBank: [ACWH00000000](#)).

HM-222D has been qualified for PCR applications by amplification of approximately 1500 bp of the 16S ribosomal RNA gene.

**Material Provided:**

Each vial contains 0.7 to 1.5 µg of bacterial genomic DNA in TE buffer (10 mM Tris-HCl and 1 mM EDTA, pH ~ 8.0). The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

**Packaging/Storage:**

HM-222D was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen on dry ice and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
