Original Source: Prevotella sp., Oral Taxon 317, strain F0108 was isolated from a healthy site of a subgingival oral biofilm

of a 38-year-old American female in 1992.¹

<u>Comments</u>: Prevotella sp., Oral Taxon 317, strain F0108 (<u>HMP ID 0670</u>) is a reference genome for <u>The Human Microbiome Project</u> (HMP). HMP is an initiative to identify and characterize human microbial flora. The complete genome of Prevotella sp., Oral Taxon 317, strain F0108 is currently being sequenced at the <u>Broad Institute</u> (GenBank: ACQH00000000).

Prevotella species are Gram-negative, anaerobic, rod-shaped bacteria commonly found in oral and vaginal flora.²

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in 0.5X Modified Chopped Meat Medium supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

HM-5 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freezethaw cycles should be avoided.

Growth Conditions:

Media:

Modified Chopped Meat Medium (ATCC medium 1490) or equivalent

Tryptic Soy Agar with 5% defibrinated sheep blood or equivalent

Incubation:

Temperature: 37°C

Atmosphere: Anaerobic (80% N₂:10% CO₂:10% H₂) Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- Transfer the entire thawed aliquot into a single tube of broth.
- 3. Use several drops of the suspension to inoculate an agar slant and/or plate.
- Incubate the tube, slant and/or plate at 37°C for 48 hours.
