# **Product Description:**

Bacteria Classification: Streptococcaceae, Streptococcus

Species: Streptococcus pneumoniae

Strain: SPEC20B

<u>Source</u>: Streptococcus pneumoniae (S. pneumoniae), strain SPEC20B was derived from a human wild-type S. pneumoniae strain by natural selection using increasing concentrations of spectinomycin.<sup>1</sup>

 $S.\ pneumoniae$  is a Gram-positive,  $\alpha$ -hemolytic diplococcal aerotolerant anaerobe that is a major cause of pneumonia, bacterial meningitis and otitis media.  $S.\ pneumoniae$  has a polysaccharide capsule that acts as a virulence factor for the organism. There are over ninety different capsular types of  $S.\ pneumoniae$  which differ in virulence, prevalence, and extent of drug resistance.

## **Material Provided:**

Each vial contains approximately 1.8 mL of bacterial culture in Todd-Hewitt broth containing 0.5% (w/v) yeast extract and 15% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

## Packaging/Storage:

NR-33664 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -80°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.
