Parents: A/Guangdong/39/1989 (H3N2) and X-88 (H6N2)

Comments: The rationale for this reassortment was to develop a high yield reassortant with a more relevant NA for vaccine use.<sup>1</sup> X-88 (Kilbourne F169) carries the N2 NA gene from A/Aichi/2/1968 and six genes encoding the internal virion proteins from A/Puerto Rico/8/1934.<sup>4</sup> X-88 is available as BEI Resources NR-3589.

**Material Provided:**

Each vial contains approximately 1 mL of pooled allantoic fluid from specific pathogen free (SPF) embryonated chicken eggs infected with reassortant influenza A virus, A/Guangdong/39/1989 (HA) x A/Aichi/2/1968 (NA) x A/Puerto Rico/8/1934 (H3N2) .

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

**Packaging/Storage:**

NR-3673 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

**Growth Conditions:**

Host: 10 to 11-day-old SPF embryonated chicken eggs

Infection: Embryonated chicken eggs must be candled for viability prior to inoculation

Incubation: 2 days at 35°C in a humidified chamber

Effect: Hemagglutination activity using chicken red blood cells and allantoic fluid from infected embryonated chicken eggs
