Parents: A/Dunedin/6/1983 (H1N1) and X-31 (H3N2)

Comments: X-31 (Kilbourne F108) is A/Aichi/2/1968 (HA, NA) x A/Puerto Rico/8/1934 (H3N2)⁴, and is available as BEI Resources NR-3483. X-31 has been shown to contain only the HA and NA genes from A/Aichi/2/1968. These two genes were replaced by the HA and NA from A/Dunedin/6/1983 (H1N1) in NR-3639. Thus, NR-3639 does not contain any genes from A/Aichi/2/1968.

Material Provided:

Each vial contains approximately 1 mL of pooled allantoic fluid from specific pathogen free (SPF) embryonated chicken eggs infected with reassortant influenza A virus, A/Dunedin/6/1983 (HA, NA) x A/Puerto Rico/8/1934 (H1N1).

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-3639 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

<u>Host</u>: 9- to 11-day-old SPF embryonated chicken eggs <u>Infection</u>: Embryonated chicken eggs must be candled for viability prior to inoculation

Incubation: 2 days at 35°C in a humidified chamber

<u>Effect</u>: Hemagglutination activity using chicken red blood cells and allantoic fluid from infected embryonated chicken eggs
