Virus Classification: *Paramyxoviridae, Pneumovirinae, Pneumovirus, Human respiratory syncytial virus*

Species: Human respiratory syncytial virus

Strain: A2000/3-4

Original Source: Human respiratory syncytial virus (RSV), A2000/3-4 was isolated from a nasal wash from an infant with RSV bronchiolitis in Nashville, Tennessee on March 4, 2000.¹

Comments: A2000/3-4 is one of six clinical RSV isolates that recently were shown to induce variable disease severity, lung interleukin-13 (IL-13) levels, and gob-5 levels in BALB/cJ mice.² IL-13 is a cytokine linked to mucus production and gob-5 is a calcium-activated chloride channel family member implicated in airway inflammation.^{3,4} Compared to mock infection, RSV A2000/3-4 infection led to high levels of gob-5 and elevation in IL-13 expression in lung tissue, but no weight loss in infected mice.²

Material Provided:

Each vial contains approximately 1 mL of cell lysate and supernatant from HEP-2 cells (ATCC® CCL-23™) infected with human respiratory syncytial virus, 2000/3-4.

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-28530 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Host: HEP-2 cells (ATCC® CCL-23™)

Growth Medium: Eagle's Minimum Essential Medium supplemented with 2% fetal bovine serum

Infection: Cells should be 60% to 90% confluent

Incubation: 3 to 8 days at 37°C and 5% CO₂

Cytopathic Effect: Rounding and sloughing
