Antibody Class: IgG2ak

Mouse monoclonal antibody prepared against the type E neurotoxin of *Clostridium botulinum* (*C. botulinum*) was purified from clone E5F8.8A hybridoma supernatant by protein G affinity chromatography. The B cell hybridoma was generated by the fusion of NSO mouse myeloma cells with splenocytes from mice immunized by intraperitoneal and intravenous injection with *C. botulinum* neurotoxin type E (BoNT/E) toxin and toxoid.<sup>1</sup>

*C. botulinum* are anaerobic Gram positive spore-forming bacteria which produce neurotoxins categorized serologically into seven types, A through G.<sup>2</sup> Four of the seven serotypes cause human botulism with the vast majority of cases due to serotypes A and B.<sup>3</sup> BoNT/E is a zinc-binding metalloprotease (holotoxin) that is endogenously cleaved into a heavy (~ 100 kDa) and a light (~ 50 kDa) chain that are held together by a reducible disulfide bond.<sup>4</sup>

**Material Provided:**

Each vial of NR-20818 contains approximately 100 µL of purified monoclonal antibody in PBS. The concentration, expressed as mg per mL, is shown on the Certificate of Analysis.

**Packaging/Storage:**

NR-20818 was packaged aseptically in screw-capped plastic vials and is provided frozen on dry ice. The product should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be avoided.

**Functional Activity:**

NR-20818 reacts with the heavy chain of botulinum neurotoxin type E in western blot assays. The antibody is also reported to be useful for ELISA, RIA, flow cytometry, immunocytochemistry, immunohistochemistry, and immunoprecipitation.
