- <u>Original Source</u>: *Escherichia coli* (*E. coli*), strain MS 145-7 was isolated in June 2002 from the diseased colon of a patient with Crohn's disease in New York, New York, USA.^{1,2}
- <u>Comments</u>: *E. coli,* strain MS 145-7 (<u>HMP ID 9348</u>) is a reference genome for <u>The Human Microbiome Project</u> (HMP). HMP is an initiative to identify and characterize human microbial flora. The complete genome of *E. coli,* strain MS 145-7 was sequenced at the Genome Institute at <u>Washington University</u> (GenBank: <u>ADWS0000000</u>).
- <u>Note</u>: HMP material is taxonomically classified by the depositor. Quality control of these materials is only performed to demonstrate that the material distributed by BEI Resources is identical to the deposited material.

E. coli is a Gram-negative rod-shaped bacterium which occurs singly or in pairs. It is a major facultative inhabitant of the large intestine.

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in 0.5X Nutrient Broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

HM-341 was packaged aseptically in cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freezethaw cycles should be avoided.

Growth Conditions:

Media: Tryptic Soy Broth or equivalent Tryptic Soy Agar or equivalent Incubation:

Temperature: 37°C

Atmosphere: Aerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- 2. Transfer the entire thawed aliquot into a single tube of broth.
- 3. Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate the tube, slant and/or plate at 37°C for 24 hours.
