Product Description:

Messenger RNA (mRNA) was isolated from *Schistosoma japonicum* (*S. japonicum*), Philippine strain, cercariae. Cercariae were collected from *Oncomelania hupensis*, that had been infected with *S. japonicum*, by the cercarial shedding technique.¹

The Philippine strain of *S. japonicum* was originally isolated from Leyte, Philippines in 1969. The laboratory stock of the Philippine strain of *S. japonicum* was later mixed with an isolate provided by Dr. Sano, Hamamatsu University, Japan in 1977 to produce the current Philippine strain of *S. japonicum*.² *S. japonicum* is a species of trematode worm which causes the chronic parasitic disease schistosomiasis.

Material Provided:

Each vial of NR-42588 contains approximately 625 ng of mRNA in DNase/RNase-free distilled water. The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-42588 was packaged in cryovials. The product is provided frozen and should be stored at -70°C or colder upon arrival. Freeze-thaw cycles should be minimized.
