<u>Strain</u>: 87-1713 Note: The label refers to this item as strain 87-1713 (10i). The (10i) is a lab designation that was used for tracking and is not part of the strain name.

- <u>Original Source</u>: *Escherichia coli* (*E. coli*), strain 87-1713 is a human isolate from Canada, 1987.¹
- <u>Comment</u>: *E. coli*, strain 87-1713 was selected to undergo complete genome sequencing at the <u>J. Craig Venter</u> <u>Institute</u>.

E. coli is a Gram-negative rod-shaped bacterium which occurs singly or in pairs. It is a major facultative inhabitant of the large intestine.

Strain 87-1713 has been typed as an enterohemorrhagic *E. coli* (EHEC) strain.¹ Many EHEC strains encode potent toxins, similar to those of *Shigella dysenteriae*, which can cause severe intestinal, kidney, and central nervous system disease.

Material Provided:

Each vial contains approximately 0.5 mL of bacterial culture in Tryptic Soy broth supplemented with 10% glycerol.

<u>Note</u>: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-17652 was packaged aseptically, in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

<u>Media</u>: Tryptic Soy broth or equivalent Tryptic Soy agar with 5% defibrinated sheep blood or equivalent Incubation:

Temperature: 37°C

Atmosphere: Aerobic

Propagation:

- 1. Keep vial frozen until ready for use, then thaw.
- 2. Transfer the entire thawed aliquot into a single tube of broth.
- 3. Use several drops of the suspension to inoculate an agar slant and/or plate.
- 4. Incubate the tube, slant and/or plate at 37°C for 24 hours.
