<u>Virus Classification</u>: *Togaviridae*, *Alphavirus*<u>Species</u>: Venezuelan equine encephalitis virus

Strain: 73U151

Original Source: Venezuelan equine encephalitis virus (VEEV), 73U151 was isolated in 1973 from a hamster in La Avellana, Santa Rosa Department, Guatemala. The virus was passaged in Vero African green monkey kidney cells.^{1,2}

<u>Comments</u>: VEEV have been classified into six major antigenic subtypes, and additional variants are described within subtypes I and III.³ VEEV, 73U151 is a subtype IE virus.¹⁻³

Material Provided:

Each vial contains approximately 1 mL of cell lysate and supernatant from *Cercopithecus aethiops* kidney epithelial cells (Vero; ATCC[®] CCL-81™) infected with VEEV, 73U151.

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-21705 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

Host: Vero cells (ATCC® CCL-81™)

Growth Medium: Eagle's Minimum Essential Medium containing Earle's Balanced Salt Solution, non-essential amino acids, 2 mM L-glutamine, 1 mM sodium pyruvate and 1.5 g/L of sodium bicarbonate supplemented with 2% fetal bovine serum, or equivalent

Infection: Cells should be 90% to 100% confluent Incubation: 1 to 7 days at 37°C and 5% CO₂
Cytopathic Effect: Rounding and detachment
