**Packaging/Storage:**

NR-3565 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

**Growth Conditions:**

Host: 9- to 11-day-old SPF embryonated chicken eggs

Infection: Embryonated chicken eggs must be candled for viability prior to inoculation

Incubation: 2 days at 35°C in a humidified chamber

Effect: Hemagglutination activity using chicken red blood cells and allantoic fluid from infected embryonated chicken eggs
