## **Product Description:**

Messenger RNA (mRNA) was extracted from *Schistosoma japonicum* (*S. japonicum*), Philippine strain, miracidia. Miracidia were collected from the livers of mice that had been infected with *S. japonicum* cercariae.<sup>1</sup>

The Philippine strain of *S. japonicum* was originally isolated from Leyte, Philippines in 1969. The laboratory stock of the Philippine strain of *S. japonicum* was later mixed with an isolate provided by Dr. Sano, Hamamatsu University, Japan in 1977 to produce the current Philippine strain of *S. japonicum.*<sup>2</sup> *S. japonicum* is a species of trematode worm which causes the chronic parasitic disease Schistosomiasis.

## Material Provided:

Each vial of NR-42587 contains approximately 625 ng of mRNA in DNase/RNase-free distilled water. The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

## Packaging/Storage:

NR-42587 was packaged in cryovials. The product is provided frozen and should be stored at -80°C or colder upon arrival. Freeze-thaw cycles should be minimized.
