Product Description:

Total RNA was extracted from *Oncomelania hupensis* (O. *hupensis*) subsp. *formosana*, Pu Yen isolate. The Pu Yen isolate, is a small freshwater snail that was initially collected in Pu Yen, Taiwan, in 1962 by Dr. Van der Schalie. It was joined with another stock from the same location in 1979. It is an intermediate host of *Schistosoma japonicum*, a species of trematode worm which causes the chronic parasitic disease Schistosomiasis.

Material Provided:

Each vial of NR-42579 contains 1 μg to 50 μg of RNA in DNase/RNase-free distilled water. The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-42579 was packaged in cryovials. The product is provided frozen and should be stored at -70°C or colder upon arrival. Freeze-thaw cycles should be minimized. Dilute with nuclease-free water to protect RNA from degradation.
