Antibody Class: IgG2ak

Mouse monoclonal antibody prepared against the Langat virus (LGTV) nonstructural protein 1 (NS1) was purified from clone 5D9 hybridoma supernatant by protein G affinity chromatography. The B cell hybridoma was generated by the fusion of Sp2/0-Ag14 mouse myeloma cells with splenocytes from mice inoculated with LGTV-infected mouse brain suspensions as described by Jacono-Connors et al. 1

This reagent is part of the Joel M. Dalrymple – Clarence J. Peters USAMRIID Antibody Collection.

Material Provided:

Each vial of NR-40304 contains approximately 100 μ L of purified monoclonal antibody in PBS. The concentration, expressed as mg per mL, is shown on the Certificate of Analysis.

Packaging/Storage:

NR-40304 was packaged aseptically in screw-capped plastic vials and is provided frozen on dry ice. The product should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be avoided.

Functional Activity:

NR-40304 is reactive in indirect immunofluorescence and western blot assays using LGTV-infected Vero cells. See Certificate of Analysis for details. This antibody is also reported to function in ELISA, to specifically recognize LGTV NS1 protein in immunoprecipitation assays, and to cross-react on Hypr virus, Kyasanur Forest disease virus, Negishi virus, Omsk hemorrhagic fever virus, Powassan virus, and Sofyn virus.¹
