<u>Virus Classification</u>: *Togaviridae*, *Alphavirus* <u>Species</u>: Venezuelan equine encephalitis virus Strain: 8138

- <u>Original Source</u>: Venezuelan equine encephalitis virus (VEEV), 8138 was isolated in 1962 in El Rincon, Panama. The virus was passaged twice in chicken embryo cells, and subsequently in Vero African green monkey kidney cells.¹⁻³
- <u>Comments</u>: VEEV have been classified into six major antigenic subtypes, and additional variants are described within subtypes I and III.⁴ VEEV, 8138 is a subtype ID virus.^{1.3}

Material Provided:

Each vial contains approximately 1 mL of cell lysate and supernatant from *Cercopithecus aethiops* kidney epithelial cells (Vero; ATCC[®] CCL-81[™]) infected with VEEV, 8138.

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

Packaging/Storage:

NR-21721 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

Growth Conditions:

<u>Host</u>: Vero cells (ATCC[®] CCL-81[™]) <u>Growth Medium</u>: Dulbecco's Modified Eagle's Medium modified to contain 4 mM L-glutamine, 4500 mg/L glucose, 1 mM sodium pyruvate, and 1.5 g/L sodium bicarbonate, supplemented with 2% fetal bovine serum <u>Infection</u>: Cells should be 90% to 100% confluent <u>Incubation</u>: 2 to 6 days at 37°C and 5% CO₂ <u>Cytopathic Effect</u>: Rounding and detachment
